### **ELIGIBILITY CRITERIA FOR THE AWARD:**

The Indian National (in the age group upto 35 years) engaged as Practising Engineer or Technologist/ Research Engineer / Engineering Teacher is eligible for the Award. The most significant and outstanding work or research contributions made should have been carried out during the past five years immediately preceding the year of the Award, for the benefit of the people of India or should represent a specific break-through in the field of Civil Engineering with specialization in Structural Engineering.

Nominations are invited from the Heads of Departments; Vice Chancellors of Universities; Directors of Research Laboratories; Industries etc. Prescribed forms may be obtained on request from the Chairman, “**L & T Dr. A. **RULES AND REGULATIONS**

**1.0 Name and style of the Award :**

***L & T Dr. A. Ramakrishna Young Engineer Award*                      **One****

2.0 To recognize significant contribution made in the field of Civil Engineering (with specialization in Structural Engineering) for the benefit of the nation.

**3.0 Nature of the Award :**

***L & T Dr. A. Ramakrishna Young Engineer Award*** ( for the age group upto 35 years)

- a) A citation to be read out at the Engineers' Day Function which will be celebrated by The Institution of Engineers (India), A.P. State Centre, Khairatabad, Hyderabad on 15th September of that year.
- b) A Certificate of the Award.
- c) A cash payment of Rs. 25,000/- to be presented at the same Engineers' Day Function.

**4.0 Eligibility and Criteria for the Award :**

- 4.1 The Indian National (age group upto 35 years) engaged as a Practising Engineer or Technologist / Research Engineer / Engineering Teacher are eligible for the "**L & T Dr. A. Ramakrishna Young Engineer Award**".
- 4.2 The most significant and outstanding work or Research Contributions made should have been carried out during the past five years immediately preceding the year of Award, for the benefit of the people of India or should represent a specific break-through in the field of Civil Engineering with specialization in structural engineering.
- 4.3 The Awards will be presented to the persons who in the final opinion of the Prize Award Selection Committee have made important and outstanding contribution, specific contribution in the field of the Civil Engineering (with specialization in Structural Engineering) work of the candidate towards the welfare of the humanity and for the benefit of People of India. For this purpose, specific contribution of individual in the field of Civil Engineering (with Specialization in Structural Engineering) will be the sole predominant criterion for evaluation.

**5.0 Nominations**

The Prize Award Selection Committee will select the recipient from the nominations received by them. The nomination should be made in the standard proforma annexed. The Prize Award Selection Committee invites nomination each year from the people authorised to nominate as per the Regulations governing the Award.

**6.0 All the decisions of the Prize Award Selection Committee are final and binding.**
